Basic Provisions

- The client represents they don't have any physical or mental conditions that might prevent them from safely riding or handling horses.
- The client further represents they aren't under the influence of drugs or alcohol, nor will they be at any time during the lessons.

Liability Release and Disclaimer

- Lessons are done at the rider or their parent/guardian's own risk
- **NEITHER NOTTINGHILL STABLES NOR THEIR REPRESENTATIVES WILL BE HELD RESPONSIBLE FOR ANY LOSS, DAMAGE, THEFT, INJURY OR DEATH SUSTAINED BY HORSES, RIDERS, THE PUBLIC OR THEIR PROPERTY.**
This includes the rider/ client's personal property, own tack and horse if rider owns the horse
- Hard hats are to be worn at all times during lessons by children under the age of 16. If over 16 it is a personal choice and the rider accepts increased risk and full liability should an injury occur.
- The client agrees to indemnify Nottingham Equestrian Estate and its representatives from any third party claims made by other parties with regards to the client (health insurance companies etc.)

Authorization for Medical Treatment

- Client agrees the instructor can seek medical treatment in an emergency and the client agrees to pay for medical treatment, regardless of whether client's insurance covers the cost.

Lesson and Agreement Cancellation Policy

- If the client wishes to cancel a lesson they must do so 24hours prior to said lesson. It is the client's responsibility to arrange a makeup lesson with their instructor at a time that suits both the client and instructor.
- Lessons will not be carried over to the next month. Make up lessons have to be in the same month it was missed.
- If cancellation is done closer to the time or on the day of the lesson, the client will forfeit the lesson.
- This agreement can be cancelled at any time by the client or Nottingham Equestrian Estate, given it is done in writing with one calendar months' notice.

Payment terms

- Lesson statements will be sent to you between the 24th and 30th of every month.
- Lessons are to be paid one month in advance, no later than the 5th of every month.
- Payment can be done via EFT (Preferred) or cash (Please make sure the instructor gives you a cash receipt)
